The Volunteer further agrees to indemnify and hold harmless the District, its officers, managers, directors, officials and employees for all claims, awards, damages, judgments and attorneys fees and costs awarded and assessed against the District, its officers, employees and agents as a result of the Volunteer's unauthorized disclosure of information, or the willful or negligent failure to comply with any rule, procedure, instruction or order of the District during the performance of and within the course and scope of this agreement. The Volunteer understands that the Volunteer acquires no property rights or interest in the services performed and may be released from service or have their services terminated at any time for any reason without recourse by the Volunteer.

The VOLUNTEER must identify if they have EVER pled guilty or no contest, been convicted of a crime, placed on probation, or given a suspended sentence or deferred prosecution, including but not limited to offenses involving driving while impaired; possession, use or sale/distribution of controlled substances, worthless check, domestic violence or other felony or misdemeanor, even if resolved outside of court. NOTE: Exclude minor traffic violations and juvenile offenses if records legally sealed. A conviction will not necessarily disqualify you from volunteering.
